This Regional tournament is sponsored by the Southern Oklahoma Sportsman's Club, and is registered with the National Rifle Association.

Location: Located at the Southern Oklahoma Sportsman's Club complex, situated off of Hwy 7 East of I-35.

Rules: Current NRA Small Bore Rifle rules will govern

Eligibility: Individual membership in the NRA is desired, but not required. Competitors must possess a valid NRA classification in either this discipline, three-position rifle, or high-power rifle, or show proof that they have competed in a conventional (or metric) prone or three-position rifle match.

Registration: Registration will be accomplished by using the attached entry form, accompanied by a check for the appropriate amount. Entries received without payment will be considered a post-entry.

Entries Close: Entry forms and fees must be **received** by April 10, 2013. Post-entries (entries received after April 10th) will be accepted up to range capacity prior to initiation of firing on each day. There is no late fee for post-entries.

Range Capacity: Range capacity for this tournament is twenty-four competitors (two relays)

Team Match: There is no team match at this Tournament.

Practice: The range will be available at 1300 hours on Friday, April 12th, for those who wish to verify zeroes and familiarize themselves with the range. Contact C. Warren Truver (at the range) prior to firing.

Entry Fees: Make all checks payable to C. Warren Truver; NRA award points are not accepted.

NOTE: \$9 of the entry is the NRA fee

Refunds: A full refund will be made to those who cannot attend and notify the Match Director by April 11th. No refunds for no-shows.

- Classification:** NRA classification system will be used in all matches; assigned and temporary classifications may be used. Unclassified competitors will compete in the Master class, unless there are enough unclassified competitors to constitute a class.
- Rifles:** Rifle to conform to rule 3.2
- Sights:** Iron sights (rule 3.7a) for matches 1 thru 4; any sights (rule 3.7a or b) for matches 6 thru 9
- Targets:** 50 yard – A23/5
50 meter (reduced) – A27
100 yard – A25
- Coaching:** Coaching during firing is not allowed.
- Sighting Shots:** Fouling and sighting shots are permitted at any time during a stage. There is no additional time allowed for sighting shots; they must be taken within the time allowed to complete the match stage
- Wind Indicators:** The Match Director will place wind flags at approximately the 50 yard line and 75 yard line, in essentially the midpoint between the number 7 and number 8 target frames. Competitors may use wind indicating devices at the firing line, so long as they do not interfere with other competitors or range operations.
- Match Operations:** Each relay will complete both stages of a match before the next relay is called to the line. If there are insufficient competitors to have two relays, there will be a twenty minute rest period between matches.
- Squadding:** Competitors will be squadded by the Match Director. If there are two relays, the order of firing will be reversed for Sunday's matches.
- Challenges:** A fee of \$1 will be charged for each challenge, which fee will be returned if the challenge is upheld. Challenges will be initiated only for a shot value; a challenge is not necessary for a competitor to point out an administrative error (wrong total listed, etc).
- Challenge Period:** The challenge period for each match will begin when the scores for that match are posted, and will end one hour thereafter. Challenges will be initiated by notifying the Statistical Officer or Match Director within the allotted time; the target may not be reviewed until all firing is completed at the end of the day
- Course Of Fire:** Conventional 3200 smallbore prone per rule 7.2. Each match will consist of two stages, with twenty rounds for record in each stage.
- Schedule:** Saturday, April 13th, metallic sights – firing begins at 0830
Match 1 – 40 rounds at 50 yards
Match 2 – Dewar course (20 rounds at 50 yards, 20 rounds at 100 yards)
Match 3 – 40 rounds at 100 yards
Match 4 – 40 rounds at 50 meters (reduced to 50 yards)
- Sunday, April 14th, any sights – firing begins at 0830
Match 6 – 40 rounds at 50 yards
Match 7 – Dewar course (20 rounds at 50 yards, 20 rounds at 100 yards)
Match 8 – 40 rounds at 100 yards
Match 9 – 40 rounds at 50 meters (reduced to 50 yards)

Aggregates: Match 5 – Iron Sight Aggregate (combined scores of Matches 1, 2, 3, & 4)
Match 10 – Any Sight Aggregate (combined scores of Matches 6, 7, 8, & 9)
Match 11 – Regional Championship (aggregate of Match 5 & Match 10)

Award Schedule: The NRA provides medallions for Match 11 (Regional Championship):

Winner – NRA Regional Gold Medallion (with a minimum of 8 shooters)
2nd Place – NRA Regional Silver Medallion (with a minimum of 10 shooters)
3rd Place -- NRA Regional Bronze Medallion (with a minimum of 15 shooters)

Match awards will be presented according to the following schedule.

Matches 1 – 4 and 6 – 9

Match winner – points (requires a minimum of 8 shooters)
2nd – 2 points (requires a minimum of 10 shooters)
3rd – 1 point (requires a minimum of 15 shooters)

Matches 5 & 10

Match winner – \$7 (requires a minimum of 8 shooters)
2nd – \$5 (requires a minimum of 10 shooters)
3rd – \$3 (requires a minimum of 15 shooters)

Classification awards will be presented according to the following schedule. Place winners may not be awarded a classification award for Match 11: match place winners may not be awarded a classification award for that match. A minimum of five shooters is required to “make” a class; classes may be combined if necessary.

Matches 1 – 4 and 6 – 9

1st in class – 3 points (requires a minimum of 3 shooters in class)
2nd in class – 2 points (requires a minimum of 7 shooters in class)
3rd in class – 1 point (requires a minimum of 13 shooters in class)

Matches 5, 10 & 11

1st in class – 4 points (requires a minimum of 3 shooters in class)
2nd in class – 2 points (requires a minimum of 7 shooters in class)
3rd in class – 1 point (requires a minimum of 13 shooters in class)
